Dear Riverview Families,

I hope you are enjoying these last few weeks of summer. We are so excited for your students' arrival and the start of the 2022-2023 school year!

This letter is to inform you of your move in time and the protocols that must be followed on **Saturday, September 10th, 2022.**

Each student will be given a time and location in which you may arrive on campus. Dorm assignments and the Who's Who letter will be provided to families the week of opening weekend via email. Families will receive a copy of their student's academic schedule upon arrival.

- MS/HS families screening and medication drop off will take place in the Hunter Commons of the James Center.**
- GROW families screening and medication drop off will take place at Trulaske.**
- HCC will give all students and families an entry pass that they can bring to their assigned dorm once they have been cleared. No-one will be allowed in a dorm without an entrance pass.

All families will have (**1 hour**) to move your student into the dorm. We will allow a maximum of 3 parents/helpers to enter the dorm upon move-in with their student. Prior to coming to campus on opening day, we request all parents/helpers do a Rapid Antigen Self-Test. This will enable parents to safely move their students into the dorms without wearing a mask and not put others at risk for COVID exposure. We will not be collecting these results, but your cooperation is appreciated.

A **NEGATIVE COVID PCR** test for any student who has not tested positive for COVID within the past 90 days will be required. All tests should be done **ON**, or **AFTER**, Tuesday, September 6th.

- Please email results AND bring a hard copy of the negative test results to submit to HCC as we will not have the ability to check email while we are checking students in**
- Air Travel Students must submit their negative PCR test results prior to departure**

**All families should check in at the HCC Screening location noted above.**

Every person while on campus is required to:

- Self attest that you do not have any signs of the following symptoms:
  - Fever (temp 100.4 or greater) or Chills
  - Cough
  - Shortness of breath or difficulty breathing
  - Fatigue
  - Muscle or body aches
  - Headache
  - New loss of taste or smell
  - Sore Throat
  - Congestion or runny nose (outside of baseline)
  - Nausea, vomiting or diarrhea

***If there has been a change in your student's medications/supplements, please update Magnus AND include a paper copy of the new order in their individual medication bag.***

If you are delayed, or miss your check-in time for any reason, please contact me as soon as possible.

With all this being stated, we would like you to know that your student should arrive at Riverview on **Saturday, September 10th** at **your scheduled time** to be screened in.
